cooperative and the area it serves. BARC has joined over 300 other rural electric cooperatives across the country in taking on the initiative to bring broadband to underserved and unserved rural areas, bringing a revival of the cooperative spirit from the 1930s with rural electrification. Our crews have an extremely challenging terrain to work in the dense forestation, rocks, hills and valleys they face not only in right-of-way maintenance, but storm and outage restoration is no easy feat. Coming from Northwestern Electric Cooperative, where all lines are accessible by either bucket truck or track machine, it is amazing to watch our crews navigate inaccessible areas to restore power to our members. Also commendable are the precautions and safety measures they take to ensure their crews and themselves make it home safe. With safety as a top priority at BARC, we are proud to have a safety to help loss prevention coordinator join the team and keep the cooperative accountable.

BARC is pursuing its first battery storage project, a 5-megawatt project in partnership with our power supply cooperative, ODEC, at our Hot Springs substation in Bath County. This project will defer costly and inefficient grid improvements while

injecting backup power and additional reliability to the members we serve in the Hot Springs area. We are also continuing our dedication to enabling our members' access to renewable energy by installing a new solar array in Rockbridge Baths, which will expand our award-winning community solar program. BARC has also developed innovative new relationships with Davey Resource Group, as our contract foresters, and Asplundh Tree Experts to expand and improve our entire vegetation maintenance program. Our broadband expansion continues; we have over 1,000 miles of construction planned over the next three years with the next year passing 13,000 locations — surpassing our total number of electric meters. This is an astounding accomplishment in just four years of BARConnects being in business.

Despite continuing global pandemic concerns, unstable economic conditions and supply chain shortages, BARC managed to end the year in the black and maintained a stable financial standing. Our staff continues to adapt, improve and innovate new ways to meet the challenges

# Sen. Warner Discusses Rural Broadband with Local Co-ops and Stakeholders

hile visiting the Shenandoah Valley in July, Sen. Mark Warner held an event hosted by Craig-Botetourt Electric Cooperative in Craig County to discuss rural broadband. Representatives from Craig-Botetourt Electric Cooperative, Botetourt County, BARC Electric Cooperative, elected leaders and community members attended the event to discuss the remaining digital divided areas in Virginia. The discussion focused on remaining areas where a gap in broadband infrastructure exists and current plans to provide universal coverage through use of federal funding made possible through the bipartisan infrastructure law and American Rescue Plan.

During the roundtable conversation, Sen. Warner listened to concerns from cooperatives and community leaders and members regarding some of the issues co-ops face as they work to construct and deploy broadband infrastructure both inside and outside of their electric service areas.

BARC representative, Tish Blackwell, discussed some of the challenges cooperatives face including supply chain issues, high costs for materials and labor, obtaining necessary permits to cross railroads and protected lands and terrain in southwest Virginia. Warner acknowledged these issues and knows every industry is experiencing supply chain challenges and high costs. "This is just one of the reasons I'm working to get our bipartisan innovation bill finally passed through Congress. While it won't be like flipping a switch, getting this bill done will help us ease some of those bottlenecks and bring down costs across the board," said Warner.

Warner's visit took place on the heels of the June announcement of the American Rescue Plan of \$219.8 million in broadband funding for Virginia, which comes from the \$10 billion Coronavirus Capital Projects Fund authored by Warner and included in the American Rescue Plan.

"Once the funding has been allocated, we'll need to focus on one of the hardest parts of the job, with help from the Department of Housing and Community Development, ensuring funds are spent wisely and that the money does lead to universal broadband in the commonwealth," Warner stated.

Dr. Tamarah Holmes and Chandler Vaughn with DHCD were also on hand at the event to discuss federal funding being allocated to Virginia and answer questions related to Virginia Telecommunications Initiative grant funds for 2023.




### Fair Season is Back
